SYNOPSIS OF PROPOSAL: To permit a farm help accommodation (temporary trailer) in the

front yard and with a size smaller than 80 sqm, contrary to Zoning By-law 03-57, Section 3.3(e), which requires accessory dwellings in non-residential zones to be at the side or rear, and Section 3.3(b), which mandates a minimum size of 80 sqm.

have filed with the secretary-treasurer a written request for notice to the Committee of Adjustment at the above noted address according to Section 45(10).

The Planning Act requires that you be notified that if a person or public body who has an interest in the matter files an appeal of a decision of the Committee of Adjustment in respect of the requested minor variance the Ontario Land Tribunal (OLT) may dismiss all or part of the appeal without holding a hearing under section 45(17) of the Planning Act, R.S.O. 1990.

## EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED MINOR VARIANCE A/21/24

An application has been submitted under File No. A/21/24 for a Minor Variance to Township Zoning By-law No. 03-57. The proposal seeks to permit a farm help accommodation (temporary trailer) to be located in the front yard, contrary to Section 3.3(e) of Zoning By-law No. 03-57, which requires accessory dwellings in a non-residential (Rural) zones to be located to the side or rear of the main building and to have a minimum size of 80 sqm. The proposed trailer exceeds this size requirement. The trailer is to be situated west of the primary dwelling and 20.05 meters from Concession 2. The primary dwelling is set back approximately 450.3 meters from the road.
