



Notice of Project Commencement Loretto Heights Watermain Replacement Contract No. 2024-004T Township of Adjala-Tosorontio

Thursday, July 18, 2024

To Whom It May Concern,

This notice is to advise you that the Township of Adjala-Tosorontio has retained Wyndale Paving Co. Ltd. to complete the Loretto Heights Watermain Replacement Project (Contract No. 2024-004T). Starting on Monday, July 29, 2024 and lasting for approximately two (2) months, Please note that the construction schedule is subject to change based on unforeseen circumstances (i.e., weather and site conditions).

Funded by the Township of Adjala-Tosorontio and the Investing in Canada Infrastructure Program (ICIP) of the Government of Canada and the Government of Ontario, this project includes the removal and replacement of the watermains and all water services amongst other appurtenances on Simon Drive and Henry Court. Watermains are the underground pipes that deliver water from the pumphouse to individual water services while water services are the underground pipes that deliver water from the watermain to curb stops on the boundary of individual properties respectively. The map below shows the project location.



In order to address frequently asked questions, Table 1 – Questions and Answers below provides answers to frequently asked questions including temporary road closures, temporary water piping, water service disruption, garbage/recycling and site restoration.

Table 1 – Questions and Answers

Questions	Answers
Temporary Road Closures	There will be no permanent road closures for the duration of the project; however, there will be temporary road closures on a daily basis. Excluding unforeseen circumstances, these temporary road closures should not last longer than the duration of daily work hours from 7 a.m. to 7 p.m. (Monday to Friday).
Temporary Water Piping	Temporary water piping will be installed above-ground to supply water through the hose bib (outside hose tap) on your home for the duration of the project. This temporary water piping replaces the delivery of water through the watermain and water services while they are being removed and replaced.
Water Service Disruption	From time-to-time, the water supply to your property will be shut-off to complete construction. The contractor will endeavor to provide at least 24-hours advanced notice but emergency shutoffs may also be required to complete the work. It is recommended that you temporarily disconnect any water treatment systems (i.e., softeners or filters) as they could be damaged during construction.
Garbage/ Recycling	Please continue to take out garbage as per your normal routine. If required, the contractor will move the bins to an appropriate location in the morning and return them in the afternoon. Please ensure that bins are labelled with your address so that they can easily be returned to you.
Site Restoration	Property owners should remove items located within Township property limits (boulevard) to avoid damage. This includes items such as landscaping (plants and pavers) and decorative objects. All Township property will be re-sodded and/or re-asphalted at the end of the project.
